### 1. LICENCE.

You may neither transfer any part of the Product nor otherwise make it available to anyone else, nor may you modify, imitate, disassemble, decompile, reverse engineer, revise or enhance the software, the production key or other part of the Product or attempt to discover the software's source code.

ARCHIBEL S.A. remains also the sole and unique owner of all information available in the Product (content, data, articles, files, icons, illustrations and original images, photos, diagrams, etc.), as well as trademarks, trade names, domain names, logos, etc. therein.

Any infringement of intellectual property rights may lead to legal proceedings.

### 2. LIMITED WARRANTY.

ARCHIBEL S.A. warrants the following: (a) that the Software will perform in substantial compliance with the users manual, provided that it is used on the computer hardware and with the operating system for which it was designed; (b) that the magnetic media on which the Software is distributed is substantially free of significant defects in material and workmanship; and (c) that the protection key (Warranty 6 months) is substantially free from significant defects in material and workmanship.

### 3. LIMITATION OF REMEDIES.

ARCHIBEL S.A. does not represent or warrant that use of the Products will be uninterrupted, timely, secure or free from error, from bugs or loss of data or will not suffer of data failure.

In the event of a breach of this warranty, ARCHIBEL S.A.'s sole obligation, at its discretion, is to replace or repair, any defective Product or component thereof, free of charge, or to refund the cost of the defective Product less freight and normal handling charges..

Warranty claims must be made in writing during the Warranty Period and within seven (7) calendar days of the observation of the defect, accompanied by evidence satisfactory to ARCHIBEL S.A. All Products should be returned to the ARCHIBEL S.A. distributor from which they were purchased (if not purchased directly from ARCHIBEL S.A.) and should be shipped by the returning party freight and insurance paid.

**4. LIMIT OF ARCHIBEL S.A. LIABILITY**

ARCHIBEL S.A.'s entire liability for damages to you or any other party for any cause whatsoever, whether in contract or in tort, including negligence, shall not exceed the price you paid for the Product that caused the damages or that are the subject matter of, or are directly related to, the cause of action. In no event will ARCHIBEL S.A. be liable for any damages caused by your failure to perform your obligations, or for any loss of data, profits, savings, or any other consequential and incidental damages, even if ARCHIBEL S.A. has been advised of the possibility of damages, or for any claims by you based on any third-party claim.

**5. CONFIDENTIALITY**

Such information shall remain the exclusive and entire property of ARCHIBEL SA. This obligation shall survive cancellation, termination or nullity of the Agreement and shall continue to apply for an unlimited period of time.

**6. PERSONAL DATA PROTECTION AND PRIVACY**

You expressly agree that the personal / private data (linked to you as an individual) that you enter on the order form sent to ARCHIBEL S.A. or that you provide when you interact with ARCHIBEL S.A. (by phone, e-mail, etc.) are used by ARCHIBEL S.A. to process your order(s) and to customize and enhance communication i.e. through newsletters or e-mails that you agree to receive by accepting this Agreement and/or by installing the Product. **8. APPLICABLE LAW AND COMPETENT JURISDICTION**

Belgian law will govern any relationship between you and ARCHIBEL S.A.  
In the case of a dispute, the Court of Namur shall be competent.
